

Legislative History of the Industrial Aggregate Index (IAI) in the *Judges Act*

- First introduced in 1981 in Bill C-34 (32nd Parliament, 1st Session – S.C. 1980-83, c. 50, s. 12), a bill that included amendments to many parts of the *Judges Act* touching on salaries, pensions, county/district courts, and other matters. At the time, the section that is now section 25 was section 19.
- When first introduced, the “Industrial Aggregate” was called the “Industrial Composite”.
